

Release from liability and waiver of all claims

The Company, Instructor or Pilot in Command:

The presence of signed waivers does not remove or transfer the company, instructor, or tandem pilot's legal obligation to discharge all duties of care you owe, including the duty to ensure that risks to health and safety are eliminated or minimised, so far as is reasonably practicable.

Hang glider and Paraglider Training and or Trial Flight

WARNING: Under New Zealand law it is extremely unlikely that you will be able to sue anyone if you are injured. New Zealand's Accident Compensation scheme provides limited assistance for injury. Visitors to New Zealand are strongly recommended to have full insurance covering injury, illness and cancellation.

I acknowledge that there are inherent dangers in participating in the sport of Hang Gliding and Paragliding. I willingly accept all the risks of Hang Gliding and or Paragliding, including without limitation the risks and the possibility of personal injury, death, property damage or loss resulting there from for any reason. I acknowledge that the enjoyment and excitement of hang gliding and or paragliding is derived in part from the freedom of flight and that the Inherent Risk of flying contributes to such enjoyment and excitement.

I agree to comply with all rules and regulations pertaining to the sport of Hang Gliding and Paragliding and to follow all reasonable safety instructions provided to me by the company, instructor and or pilot in command, before and during my training and or whilst in flight.

The company, instructor or pilot in command, puts safety in operations first, and have the authority to remove a person from activities, who in their opinion is likely to endanger themselves or others. This exclusion includes the use of alcohol and/or recreational drugs or medication. I also recognise that the company, instructor or pilot in command, reserves the right to cancel, modify, or curtail any training or trial flight, if my safety or that of any other person becomes a concern.

I accept that all liability for loss of or damage to my property, disruption to travel plans, physical or mental injury is excluded. This exclusion is subject to any rights or remedies a customer has under the Consumer Guarantees Act 1993, or any other New Zealand law.

I certify that I am of sound mind, physically fit and healthy, free of medication and the information I have provided on my student membership enrolment form regarding Medical Condition/s or other information is correct.

By accepting this waiver, I confirm that I am of the Age of Majority and that I have read and understood this agreement and agree that this agreement will be binding upon my heirs, next of kin, executors, administrators and successors. If under the age of 18 years, a parent or legal guardian must sign to accept this waiver.
